Regions of new development (RND) are regions characterized with specific conditions and prerequisites for economic development. They determine specific development forms, methods, institutions, and processes, which produce a unique complex of interrelated social and economic activities, natural resource use practices and environment management technologies.

In contrast to earlier developed regions or those of pioneer developments, regions of new development have established support base for further development and certain ecological, social and economic relations. In their preceding development RND are mostly resource based regions with highly concentrated and extremely diverse resources. Further economic development of these areas and thus their prospects are aimed at restructuring the existing relations within the adopted policy guidelines.

Modern economic and geopolitical trends in the world and every country need working out environmental policies, adequate to implemented activities to improve economic development of RND.

Main topics to be discussed:

1. Theoretical basis for developing regional environmental policy (REP) in RND, including:
 - GIS support for REP development and implementation;
 - evaluation of REP efficiency: criteria and methods;
 - ecological indicators of RND sustainable development in REP
2. REP in the system RND resource use
3. Environmental policy of urban and urban-industrial areas in RND
4. Importance and specifics of tourism development in RND strategies

Requirements for Papers

Papers should be copyrighted materials within 7 pages (A4 format), including figures, tables and references. Please use Times New Roman (12 point) with single space lines (Format RTF), page margins of 25 mm all around and paragraph break of 12,5 mm. References in the text are indicated with the reference number in square brackets. Title of the paper (bolded capitals), author's name and affiliation are written followed by next line. The paper should contain abstracts not exceeding 700 characters. Only two papers from the author are accepted (including co-authorship).

Presentation papers sent will be published electronically before the Conference.

Plenary session presentation papers and those approved by the Organizing Committee will be published as a volume of Conference Proceedings.

The Organizing Committee retains the right to deny applications and materials inconsistent with Conference topics.

Registration Fees.

The fee of 100 dollars for participants in presence and 50 dollars for post graduate students should be paid in cash at the registration. The payment details will be indicated in the 2nd circular.

Registration fee includes conference participation and materials.

Several tours will be organized for Conference participants. Conference tours will be announced in the second circulation letter and are to be paid during the Conference.
